- I. BBazaar’s acknowledgement email sent to you when your application was referred to the bank.
- II. A scanned copy or photograph of the credit card approval letter received from the bank (this is the letter that your credit card is attached to). You must block out/hide your credit card number and other sensitive information on the approval letter before sending the copy of approval letter to us. However, the name, address and letter date must be clear and legible.



- III. A scanned copy of proof of activation of the credit card via photography or screen copy of the card activation message received by the customer from the bank through SMS.

Gift Redemption Period
