- I. For Category I credit cards, your choice of voucher between Ikea Gift card or Lazada Voucher of RM200 value.
- II. BBazaar's acknowledgement email sent to you when your application was referred to the bank (for both Category I and Category II).
- III. A scanned copy or photograph of the credit card approval letter received from the bank (this is the letter that your credit card is attached to). You must block out/hide your credit card number and other sensitive information on the approval letter before sending the copy of approval letter to us. However, the name, address and letter date must be clear and legible (for both Category I and Category II).
- IV. A scanned copy of proof of activation of the credit card via photography or screen copy of the card activation message received by the customer from the bank through SMS. You must block



out/hide your credit card number and other sensitive information in such proof of activation (for both Category I and Category II).

Voucher Redemption Period

- In order to be eligible to receive the Voucher, customers need to email their Voucher redemption claim along with the listed documents before the end of the next month following their application, or 60 days from the date of card approval (as per credit card approval letter) and card activation, whichever is later.

When will you get your Voucher(s)
